Please note that each child's place on the trip is dependent on them maintaining high levels of attendance and meeting Smithdon's behaviour expectations. If allocated a place, Smithdon High School reserves the right to withdraw your child's place at any time, if either of these things become a concern. In this instance, any payments made will be non-refundable unless a suitable replacement is found.
